- 3. Promote the rights of children and youth as per the United Nations Convention on the Rights of the Child (UNCRC).
- 4. Address the overrepresentation of Indigenous children in the child welfare, children's mental health and youth justice domains.
- 5. Advance CWLC as a national membership organization.

Strengthening Services for Children and Youth

The CWLC works throughout the year on projects supporting the strategic plan and vision of the organization. In addition to working within Canada, the CWLC, in collaboration with its member agencies, is recognized internationally as being a leader in the field of child and youth welfare and has been approached to work with provinces and territories, other countries and international organizations. A sampling of our work during 2015 is highlighted below.

Northwest Territories Workload Management Initiative

Funder: Department of Health and Social Services, Government of Northwest Territories
CWLC worked with the Government of the Northwest Territories to develop a workload and caseload management study in child protection. In 2014, the CWLC conducted site research that included interviews with child protection workers, supervisors, managers, and executive level staff. Detailed file reviews were also conducted to determine file completeness.

The CWLC worked with one of our members, Dr. Grant Charles (UBC), as a technical consultant on the project. He was assisted by MSW Candidate, Michelle Haywood-Farmer (UBC). The final report was delivered and approved by the Department of Health and Social Services.

Mapping and Promoting the Use of Federal Family Violence Surveillance Data

Funder: Public Health Agency of Canada CWLC has been working with the Public Health Agency of Canada (PHAC) to examine nation level data on child maltreatment and intimate partner violence and its use by government departments and agencies. The goal of this project will be to supplement policy, program, and research on the existing family violence data collected at the

federal level for the Public Health Agency of Canada (PHAC). This data will serve as a basis for discussion with Family Violence Initiative (FVI) members to inform them on family violence prevention efforts and priorities at the federal level. The project is in its third phase and our next steps include optimizing family violence information.

Preventing Child Labour Through Child Protection

Funder: Eliminating Child Labour in Tobacco Growing (ECLT) Foundation, Switzerland CWLC was invited by the Eliminating Child Labour in Tobacco Growing (ECLT) Foundation to provide technical assistance to support their work on child protection capacity development in Tanzania. The CWLC is working alongside key international, national, and district level stakeholders, including: UNICEF Tanzania; the Prime Minister's Office of Tanzania; Federal Departments Tanzania; and, other social service organizations. CWLC developed program content for an expert panel on Child Labour Prevention Through Child Protection. The panel was convened at the 2015 National Sustainability Conference Pathways to Sustainability: Together We Can Eliminate Child Labour in Agriculture.

South Africa Child Protection Surveillance Study

Funder: Department of Social Development, Republic of South Africa

CWLC has been working in collaboration with the South African Department of Social Development (DSD) to provide technical support to the development of a national data collection and analysis system on child abuse. Most recently the CWLC has provided technical assistance in designing and developing a sustainable costing method to support ongoing surveillance and research in child abuse for South Africa's Department of Social Development.

Child Protection Practice and Policy Review: British Columbia

Funder: Ministry of Children and Family Development, British Columbia

The CWLC has been contracted to support the British Columbia Ministry of Children and Family Development. The work includes reviewing legislation, policies and standards with respect to child protection practice in cases involving custody and access disputes, and assess the level of guidance and support given to staff. The CWLC has obtained the expertise of Dr. Deborah Goodman of the Child Welfare Institute to provide technical expertise on this Review.

Future Directions in Preventing Child Abuse and Domestic Violence Conference

Funder: Ministry of Children and Family Development, British Columbia

The CWLC is assisting with the planning of a national conference on child abuse and domestic violence. The forum topics will address and advance information on child welfare, with specific attention given to: improved collaboration between child welfare and domestic violence service responses; strengthened integration of the needs of front-line professionals and the imperatives of

the policy and legislative context; and, enhanced victim-sensitive and culturally-valid service delivery.

The conference will be held May 2-4, 2016 in Vancouver, British Columbia.

Protecting Children through Improved Child Abuse Reporting

Funder: Ministry of Children and Family Development, British Columbia

The CWLC has been contracted by the Ministry of Children and Family Development in British Columbia to review and provide technical input on its child abuse reporting framework. The Ministry has contracted with the CWLC to review and advise on public education materials that may be distributed through the campaign. Additionally, CWLC will be advising on the implementation of strategies to facilitate public reporting.





Partnerships

The CWLC magnifies its professional footprint by working collaboratively with some of the leading organization in our domain in Canada and across the globe. Some the the key partnerships are highlighted below:

Child Welfare League of America (CWLA)

The CWLC and the CWLA have a longstanding mutually beneficial strategic partnership. CWLA leads and engages a network of public and private agencies and partners to advance policies, best practices and collaborative strategies that result in better outcomes for vulnerable children, youth and families. CWLA is a coalition of hundreds of private and public agencies serving vulnerable children and families. Our two organizations share expertise, resources and access to learning opportunities. Future collaborations will focus on knowledge mobilization and conferences and training.

Youth in Care Canada (YCC)

Youth in Care Canada (YCC) is a strong partner of the CWLC. They are a vibrant organization driven by youth and alumni of the child welfare sector. Youth in Care Canada's mandate is well summarized in their expression, 'Making Connections and Making Change'. Youth in Care Canada exists to voice the opinions and concerns of youth in and from care and promote the improvement of services for them. They are the only national constituency-driven consumer-focused organization in the child welfare sector. They are also the longest-running national child welfare organization in Canada, and the oldest national youth-directed organization in the country.

National Guidance and Implementation Committee (NGIC) for the Development of Pan-Canadian Guidance on Family Violence

CWLC is a partner in the National Guidance and Implementation Committee (NGIC) for the Development of Pan-Canadian guidance on Family Violence. An inaugural meeting was held June 11-12, 2015 in Ottawa. This multi-year project is part of a Government of Canada's investment to address family violence from a public health perspective. The NGIC project is structured as a partnership with the

British Columbia Centre of Excellence for Women's Health (BCCEWH) and the Preventing Violence Across the Lifespan (PreVAiL) Research Network. The primary objective among partners is to engage in a process to produce up-to-date, evidence-informed guidance, curriculum and practice tools of optimal use to their member organizations that will lead to better outcomes for those who experience violence.

International Forum on Child Welfare (IFCW)

The mission of the IFCW is to work for children worldwide to improve the quality of their lives,

and to enhance opportunities for the development of their full potential. This mission includes a commitment by IFCW's members to work for the fulfillment of the Convention on the Rights of the Child. Strengthening non-governmental child welfare organisations worldwide is a key focus of the IFCW.

The CWLC holds the Treasurer position for the International Forum on Child Welfare and has supported the Forum's operational and planning agenda.

Supporting Indigenous Children and Youth

The CWLC is involved in a number of initiatives pertaining to Aboriginal Children and Youth. Our goal is to address the needs of vulnerable Aboriginal Children and youth by increasing understanding, knowledge exchange and action regarding Aboriginal child and youth issues.

Enhancing Prevention: Development of a Needs Assessment for an Enhanced Prevention Model

Funder: Innu Round Table Secretariat (IRT), Labrador The CWLC is working with the Innu Nation on developing a needs assessment for an Enhanced Prevention Model for the delivery of child welfare prevention services. The needs assessment will include an environmental scan and a mapping exercise. CWLC is working in partnership with the Innu Nation to ensure the mapping exercise outlines the cultural strengths of the Sheshatshiu and Natuashish communities. CWLC conducted site visits in Labrador during which important data was collected with the help of community members, foster parents, Innu Leaders, the IRT, and Child, Youth and Family Services staff. The project is now in the final phase which includes reporting on the findings and recommendations.
